- ✓ The second line is **LAST NAME AND INITIALS** (the font is bold all uppercase, aligned on the right side), the name of the organization, city, country (italics, after the names of the authors);
 - \checkmark The following is the text of the theses, aligned in width, with a left indent 5 mm.
